ORDER

The Chief Engineer, Generation, as per letter read as 2nd has requested to enhance the monthly km limit of hired vehicle provided for school trips from Moozhiyar to Seethathode, to 1500km. As per the B.O. read as 1st above, the sanctioned monthly running limit for the

subject vehicle is 1200km.

It is reported that the number of school working days has been increased from 22 to 26 days in a month due to the announcement of "saturdays as working days" by the Government and due to special classes arranged by various schools. Considering total distance per day as 53km, the total trip distance will be 1378 km and additional trips are also to be engaged for participating in various school curriculum activities.

The matter was taken up with the Full Time Directors for sanction as per note read as 3rd above.

Having considered the matter in detail, the Full Time Directors through circulation, resolved to accord sanction to enhance the monthly kilometer limit to 1500 km for the hired vehicle for conducting school trips from Moozhiyar to Seethathode .
