Shifting of 250kVA transformer at Kizhakkekavala junction, Nedumkandam under Electrical Division, Kattappana – Sanction Accorded – Orders issued

ORDER

The Nedumkandam Grama Panchayath, in the meeting held on 15.02.2021, decided to request the Government to shift a transformer at Kizhakkekavala Junction, near Kumily-Munnar Highway under Electrical Division, Kattappana, which is causing danger to the public.

The Chief Engineer Distribution (Central), as per letter read as 2nd above, has informed that, based on the application received from the Secretary, Merchant Association Nedumkandam, to shift the above mentioned transformer at Kizhakkekavala Junction, Administrative Sanction for an amount of Rs.12,05,502/- was issued under deposit work scheme, by the Executive Engineer, Electrical Division, Kattappana. But the Merchant Association was not willing to pay the amount. Thus a revised estimate amounting to Rs.8,92,899/- was prepared for the work. The work involves shifting of the existing plinth mounted 250kVA transformer to a convenient location in front of the Nedumkandam Police Station.

Since the place where the transformer is located is a common place of public gathering and meetings, the Tahasildar, Udumpanchola Taluk has also requested to shift the transformer to a convenient location. It is also reported that this junction is a crowded one on Kumily Munnar High way and is meeting with 3 other main roads. Taluk office, Police Station, KSRTC Depot, Panchayath, Stadium, Fire station, Hospitals, Banks, other Government, quasi Government and Private Institutions en route from this junction. Moreover, LT feeders and 11kV town feeder at this transformer structure is branched to 4 directions from this junction. Hence, in view of safety and risk, the Executive Engineer has reported that it is very necessary to shift the transformer from this junction.

Considering the above facts, the Deputy Chief Engineer, Electrical Circle, Thodupuzha has requested for shifting the transformer on public interest by meeting the expenses departmentally.

The matter was placed before the Full Time Directors as per the note read as 3rd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 25.02.2021, resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Thodupuzha to shift the transformer at Kizhakkekavala Junction, near Kumily-Munnar Highway, by meeting the expenses departmentally, considering safety and on public interest.

Orders are issued accordingly.
