### ORDER

The Chief Engineer (Transmission North), as per letter read as 1<sup>st</sup> above, reported that sanction was issued for survey reporting and disposal of 24 nos of trees in the compound of 110 kV Substation, Pudukkad (under Transmission circle, Thrissur) in connection with the installation of ground mounted solar plants under PM-KUSUM scheme. The assessed value of the trees is Rs.1,70,746/- (without GST).

Tender cum auction for the sale and disposal of the trees were conducted thrice. No one participated in the first two auctions/bids and in the third auction conducted in March 2023, even though two bidders registered, neither of them were willing to start the auction as per the assessed amount of Rs.1,70,746/- (excluding GST). The bidders were asked to offer their amount in sealed cover and the highest offered amount is Rs.40,000/- (without GST) by Sri.Prasad P.S, Pattiparambil (H) Viyyur P.O, Thrissur, which is 76.6% below the assessed value. The amount offered by the second bidder is Rs.18,000/- only.

The Chief Engineer (Transmission North) reported that the chance of getting better offer is remote even if re-auction is done and also stated that that the removal of trees are very urgent since the installation of solar plants is pending for want of site clearance. The Chief Engineer hence requested sanction for confirming the auction in favour of Sri.Prasad P.S, Pattiparambil (H), Viyyur P.O, Thrissur at his offered amount of Rs.40,000/-.

The matter was placed before the Full Time Directors as per note read as 2<sup>nd</sup> above.

Having considered the matter in detail, the Full Time Directors, in the meeting held on 11.08.2023, resolved to accord sanction for confirmation of auction for disposal of 24 nos. of trees in the compound of 110 kV Substation, Pudukkad, in favour of the highest bidder

Sri. Prasad P.S, Pattiparambil (H), Viyur P.O, Thrissur at his offered amount of Rs.40,000/- (GST extra), which is 23.42% of the assessed value.

Orders are issued accordingly.
