### ABSTRACT

### ORDER

The upgradation of 33 kV Substation, Palakkal to 110 kV was proposed to meet the increased load demand in and around the area and keeping in view the future load requirements. Accordingly, the substation was upgraded to 110 kV level with effect from 03.04.2023. The Chief Engineer (Transmission North), as per letter read as 1<sup>st</sup> above reported that one No 12.5 MVA, 110/11 kV transformer has been charged and the 11 kV feeders are operated from the new control room.

The Chief Engineer (Transmission North) requested sanction for the following staff strength at the Substation, to carry out the operation and maintenance of the substation as per the approved staff pattern for 110 kV substations:-

1	Assistant Engineer (Electrical)	5 (one Station Engineer and 4 nos operators)
2	Sub Engineer (Electrical)	1 (for maintenance)
3	Overseer (Electrical)	4 (for shift operation)
4	Electricity worker	2 (for maintenance)

The matter was placed before the Full Time Directors as per note read as 2<sup>nd</sup> above.

Having considered the matter in detail, the Full Time Directors, in the meeting held on 15.06.2023 resolved to sanction the places of officers and staff proposed above for the operation and maintenance of 110 kV Substation, Palakkal by re-deploying the optimal staff only.

Further resolved to authorize the Chief Engineer (HRM) to fill the places by re-deploying the

optimal staff.

Further resolved to accord sanction to the Chief Engineer (Transmission North) for arranging the operating personnel on work contract basis till the places are filled by re-deployment.

Orders are issued accordingly.
