## ORDER

As part of Attappady Green Corridor (AGC) project, a 33/220 kV Substation is proposed to be constructed at Kottathara to develop the transmission infrastructure for evacuation of the renewable energy generated in the Attappady area (Agali, Attappady, Kottathara) in Palakkad Dist to the grid. Sanction was accorded as per B.O. read as 1<sup>st</sup> above for the negotiated purchase of 12 acres of land at Attappady in survey nos 809/1, 811/1, 811/2 and 812/1 of Agali Village for the construction of 220 kV substation, Kottathara. The land owners had given their consent for sale the land. DLPC meeting was conducted on 12.04.2018, but the purchase could not be finalized at that time as some of the land owners failed to produce the required documents.

The Chief Engineer, TransGrid in submitting the proposal as per note read as 2<sup>nd</sup> abcve, requested sanction for acquiring 12:06 Acres of land in survey nos 811/1, 811/2 and 812/1 through LARR Act 2013 with sanction from Revenue and Power departments. The Chief Engineer recommended this land citing many advantages viz. the proposed land has a wide access road for transporting heavy equipment like transformers, the land is in the vicinity of the proposed wind plants of M/s NHPC, the land is of dry type suitable for constructing the substation with minimum land development works etc.

The matter was placed before the Full Time Directors as per note read as 3<sup>rd</sup> above. Having considered the matter in detail, the Full Time Directors in the meeting held on 17.02.2023,

Resolved to accord sanction to acquire12.06 acres (4.88 hectares) of land under the possession of five individuals in old Survey Nos 811/1, 811/2 and 812/1 in Agali Village, Ottappalam Taluk, Palakkad Eistrict for the construction of 33/220 kV Substation at

Kottathara as part of Attappady Green Energy Corridor project, by invoking the provisions under LARR Act 2013.

Further resolved to request Government of Kerala to accord sanction for acquisition of the said land by invoking the provisions under LARR Act 2013.

Orders are issued accordingly.
