ORDER

Administrative sanction was accorded as per B.O. read as 1st above for an estimate amounting to Rs.20.87 Crores for construction of a new 110 kV substation at Thimiri in Kannur District by constructing 5.5 km 110 kV line as LILO of the existing Payyannur-Cherupuzha 110 kV feeder and installing 2 Nos of 12.5 MVA,110/11 kV transformers. An amount of Rs.80 Lakh was provided in the estimate for the purchase of land.

The Chief Engineer (Transmission North) as per letters read as 2nd and 3rd above recommended to purchase the land identified in survey No. 100/262B (Re-survey Nos. 100/2624, 100/2625, 100/2626 and 100/2627) Thimiri village,Thaliparamba Taluk, Kannur district owned by Sri.T.V John and Smt. Sheena John, Thekkumcherikunnel, Kottayad.²O. Alakode.

Since the Government decision on the request for exempting KSEBL from the purview of LARR Act 2013 for land acquisition upto 5 hectares is getting delayed, it was suggested to proceed with the acquisition of the land under the provisions of LARR Act 2013. The matter was placed before the Full Time Directors as per the note read as 4th above.

Having considered the matter in detai, the Full Time Directors in the meeting held on 17.D2.2023, resolved to accord sanction to acquire 1.5 acres of land owned by Sri.T.V John and Smt. Sheena John, Thekkumcherikunnel, Kottayad P.O, Alakode in Survey No. 100/2628 (Re-survey Nos. 100/2624, 100/2625, 100/2626 and 100/2627) in Thimiri Village, Thaliparamba Taluk, Kannur district for the construction of 110 kV substation at Thimiri, under the provisions of LARR Act 2013.

Further resolved to request the Government of Kerala to accord sanction for acquisition of the said and under the provisions of LARR Act 2013.

Orders are issued accordingly.
