ORDER

The cost estimated for the power evacuation works from the 50 MW Solar park at Paivalike in Kasaragod district to 110 kV Substation, Kubanoor was ₹ 10.9 Crore. The work included "Construction of 8 km 33kV double circuit feeder with covered conductor on specially designed A poles from the 50 MW Solar Park at Paivalike to 110kV Substation, Kubanoor". The work was to be executed on deposit work basis in favour of M/s RPCKL, a joint venture company of KSEBL and SECI. M/s RPCKL made part payment of ₹ 10 Crore for the work.

After actual execution of the work, the Chief Engineer, Transmission North reported the total expenditure as ₹ 14,56,55,961/- (including GST) and revised Administrative Sanction and Technical Sanction for the same was accorded as per B.O. read as 1st above. Sanction was also accorded to the Chief Engineer (Transmission North) to issue additional demand of ₹ 4,56,55,961/- to M/s RPCKL. The Deputy Chief Engineer, Transmission Circle, Kannur issued the Invoice for an amount of ₹ 4,56,55,961/- (including GST) to M/s RPCKL as per letter read as 3rd above.

The CEO RPCKL as per letter read as 4th above has reported that out of the total demand of ₹ 4,56,55,961/-, an amount of ₹ 1,56,55,961/- was remitted by them on 27.05.2022 and requested to allow time extension for remitting the balance amount of ₹ 3 crore after receipt of CFA from MNRE.

The matter was placed before the Full Time Directors as per note read as 5th above.

Having considered the matter in detail, the Full Time Directors, in the meeting held on 12.10.2022 resolved that RPCKL shall remit the amount without any delay.

Orders are issued accordingly.
