ORDER

The Government of Kerala had announced a special compensation package for the construction of Edamon-Kochi 400 kV Transmission Line as per G.Os read as 1st to 4th above. As per the Government order, the compensation towards Tower Standing Area (TSA) shall be shared by PGCIL and KSEBL/GoK in the ratio 85:15 and that of Line Corridor shall be shared in the ratio 15:25. Further, the contribution of KSEBL/GoK shall be shared equally between KSEBL and GoK.

The Executive Engineer Transmission Division, Pathanamthitta and Nodal Officer for disbursement of compensation reported as per the letter read as 13th that, Detailed Valuation Statement (DVS) for 436 tower locations (834 holdings) for an amount of Rs.44.524 crores and DVS for 443 spans covering 5573 holdings for an amount Rs.159.598 crores towards line corridor compensation has been approved by the four District Collectors as on 30.06.2022. Out of this, an amount of Rs. 42.148 crores has been disbursed to 732 land owners towards

TSA compensation and Rs.98.498 crores has been disbursed to 3620 land holders as line corridor compensation so far. The status of assessment and disbursement of the compensation and the details of funds deposited by PGCIL and KSEBL as on 30.06.2022 are detailed below.

An amount of Rs.25.781 crores is to be allocated by KSEBL towards the combined share of KSEBL & GoK for effecting payment of the pending compensation amounts reported by the Special LA Tahsildars and transferred to the compensation disbursement account maintained by the District Collector, Ernakulam.

As per the G.O. (MS.) No. 29/2015/PD dated 30.07.15, Clause (X), it is specified that "In the first instance, the amount for implementing the special compensation package will be met by KSEBL by availing loan. The Government share will be granted subsequently".

KSEBL had so far deposited an amount of Rs.80.646 crores (KSEBL share + GoK share) to the compensation account. The share of GoK to be reimbursed to KSEBL is 50% of the above, i.e. Rs.40.323 crores. Out of this, an amount of Rs.3 crores was released by GoK as per the G.O. read as 7th and Rs.17 crore as per the G.O. read as 11th above. Therefore, an amount of Rs.20.323 crore is pending disbursement to KSEBL from GoK.

Considering the above, the Director (T,SO,P&S) recommended to allocate an amount of Rs.25.781 crores from KSEBL fund for disbursement of the pending compensation amounts and to transfer the same to the Compensation Disbursement Account maintained by the District Collector, Ernakulam through the ARU of Transmission Division, Pathanamthitta. It was also recommended to request Govt. of Kerala to reimburse its share of the compensation amount of Rs.33.213 crores (including the pending reimbursement of Rs. 20.323 crore) to KSEBL immediately.

The matter was placed before the Full Time Directors as per note read as 14th above. Having considered the matter in detail, the Full Time Directors in the meeting held on 12.08.2022,

(1) Resolved to accord sanction to allocate an amount of Rs.25.781 crore (Rupees Twenty Five Crore Seventy Eight Lakhs Ten Thousand only) from KSEBL fund for disbursement of the pending compensation amounts as reported by the Special LA Tahsildars of Kollam, Pathanamthitta, Kottayam and Ernakulam districts as part of the special compensation package for Edamon-Kochi 400 kV line construction and to transfer the amount to the Compensation Disbursement Account maintained by the District Collector, Ernakulam through the ARU of Transmission Division, Pathanamthitta.

(2) Further resolved to inform the Government regarding how KSEBL has done financial mobilization and to request the Government of Kerala to reimburse its share of Rs.33.213 crores (Rs.20.323 crores pending share + Rs.12.89 crores present share) to KSEBL immediately.

Orders are issued accordingly.
