## ORDER

The SCO Head, Jio Digital Fibre Private Limited, as per the letter read as 3<sup>rd</sup> above, has intimated that presently their requests are given centrally at KSEBL, Thiruvananthapuram to obtain permission for using KSEBL poles to draw their fibre cable across the state. It is also intimated that they are now rolling out 5G and focusing on connecting maximum households in Kerala on fibre. To speed up the current process, they have requested that Executive Engineers, may be allowed to grant permission directly for using KSEBL poles under their Jurisdiction.

Based on the request of M/s. Jio Digital Fibre Private Limited, a process flow is suggested for issuing sanction for using KSEBL poles to draw fibre cables in the case of Centrally paid TSP in addition to the existing one.

The matter was placed before the Full Time Directors as per the note read as 4<sup>th</sup> above.

Having examined the matter in detail, the Full Directors in the meeting held on 15.07.2022, resolved to accord sanction to Director (Distribution & SCM) to issue sanction for cable drawal request from the Centrally paid TSP based on the permission request received from the Executive Engineers of Electrical Divisions as done in the case of other TSP/ Cable TV providers.

Further resolved to authorize the TA to the Director (Distribution) to ensure that monthly basis consolidated list of sanctions issued in the case of centrally paid TSP is placed before the Board for ratification in the first week of the following month.

Further resolved to authorize the Secretary (Administration) to issue the demand and to ensure the execution of Agreement in this regard.

Orders are issued accordingly.
