ORDER

The Deputy Chief Engineer, Electrical Circle, Kannur as per letter read as 4th above reported that the estimate amounting to ₹ 8,17,192/- for shifting of poles under the town improvement works- (Development of Kadachira Bazar-HSS along PUKC Road with its beautification under PWD Road Section Kannur by providing Drainage, fixing of Handrails and Food Path) - has been sanctioned vide AS No. AS/6114/21-22/171 dated 24.11.2021. Demand notice for the same was issued to the Assistant Engineer, PWD Road Section, Kannur by the Assistant Engineer, Electrical section Kadachira on 25.11.2021. The work involves the erection of 12 nos of A pole, 12 nos of HT PSC poles, providing 17 Nos of HT Stay and 137 m 3 phase LT ABC Line etc.

The Deputy Chief Engineer, Electrical Circle, Kannur also informed that the works as mentioned in the BOs read 1,2 &3 had already been executed by KSEBL on a deposit work basis, after getting an undertaking from the PWD that the amount will be remitted at the earliest. The total amount pending to be paid so far is ₹50,51,971/-.

The matter is reported in print media that the Town beautification works are stopped due to the non-removal of the electric poles by KSEBL. The Deputy Chief Engineer, Electrical Circle, Kannur requested the necessary directions for the above.

Based on the direction from Chairman & Managing Director the details of amount to be remitted by PWD are collected from the field. The total amount for which the works are carried out by KSEBL (utility shifting) and still pending remittance from PWD is ₹77,12,395/-.

The matter was placed before the Full Time Directors as per note read as 5^{th} above.

Having examined the matter in detail, the Full Time Directors in the meeting held on 12.05.2022 resolved to accord sanction to request the Chief Engineer, PWD to issue sanction for Road Cutting works requested by KSEBL after accepting an undertaking from KSEBL that the amount will be remitted later.

Orders are issued accordingly.
