## ORDER

Two part e-tender was invited for the purchase of HT Aerial Bunched Cables of various sizes on variable price basis from the genuine manufacturers with PAC of Rs.114.48 Crore to meet the urgent requirement for the year 2022-23 and 2023-24. Based on PC Proceedings, letter of award for the supply of 862 km of 3X120+1X95 sq.mm HT ABC was issued to M/s.SBEE Cables (India) Ltd to proceed with their preliminary works for production.

Purchase Order read as 3 rd above was issued on 25.05.2023. As per delivery schedule in Purchase Order, the first lot of the item has to be delivered by 22.07.2023. After receiving PO, the firm requested as per letter read as 4th above for delivery schedule extension stating the difficulties in arranging the imported XLPE compound from their providers abroad. The firm was informed that their request could not be considered due to urgency of material in the field. Also the firm was informed that as the price is variable as per PO and tender, extending delivery schedule may cause additional financial burden to KSEB Limited.

Subsequently the firm pointed out some errors in PO, ie 'Guaranteed Technical Particulars offered by the firm' attached along with of PO as Annexure IV. Purchase Order Amendment -1 was given after correcting errors occurred in the Annexure IV ie "GTP offered by the supplier "based on the request of the firm. The firm requested to change PO date as PO amendment date during August 2023. The price of the raw material shows a decreasing trend during that period. Reply was given to firm as per letter read as 8<sup>th</sup> above intimating that their request to consider PO amendment date as PO date cannot be considered.

Remarks of Financial Adviser was sought upon the direction of Director (D,S and SCM) and it was opined to examine the legal point of view of whether the claim of the firm to calculate delivery period from the date of amendment order is valid. Remark was sought from LA and DEO and it was opined that if the reported changes comes under the category of procedural nature, a conservative approach has to followed treating the date of PO as 25.05.2023 itself with all consequent obligation and liabilities. But if substantial changes are made pertaining to the specification of the materials to be supplied, thereby affecting the very nature of PO, the amendment attains significance and the effective date of Purchase Order has to be altered accordingly.

Though the PO amendment is of procedural nature, considering the firm's claim that they could not start production of cables until they received PO amendment, the Chief Engineer (P & SCM) has recommended as per note read as 15<sup>th</sup> above to extend the delivery schedule based on PO amendment date as requested by the firm without imposing penalty and with price variation applicable will be such that updated basic price be based on the updated basic price for initially scheduled delivery period specified in original PO No:19/2023-24 dated 25.05.2023 or updated basic price on actual date of delivery which ever is lower.

Having consider the matter in detail, the Full Time directors

**RESOLVED** to extend the delivery schedule based on PO amendment date without imposing penalty and with price variation applicable will be such that updated basic price be based on the updated basic price for initially scheduled delivery period specified in original PO No:19/2023-24 dated 25.05.2023 or updated basic price on actual date of delivery which ever is lower.

Orders are issued accordingly.
