ORDER

A petition was received from Sri. C.M. Paulose, Cherakkunnath House, Chathamattom P.O, in Santhwanasparsham Adalath 2021, stating that his connection for agricultural purpose (LT V A) has not been effected even though he has remitted CD. The Adalath decision was to effect the connection on special order.

The Executive Engineer, Electrical Division, Muvattupuzha, as per letter as read 1st above, has intimated that the date of application for the agricultural connection, by the above applicant was on 09.08.2011 and a special CD of Rs.2000/- had been remitted by the party. The party waited for free connection under normal scheme.

This applicant was left out from effecting service connection free of cost. Later this practice of issuing free connection was denied as per the Board order as read 2nd above and it was ordered that while processing an application for supply of power from any consumer, the officers concerned shall scrupulously follow the procedure laid out in the Supply Code (2005) and collect only the rates approved by the Commission from time to time.

Hence, direction was sought for effecting the service connection for agriculture purpose, free of cost or else for refunding the already collected special deposit of Rs. 2000/-. The ECSC amount for 30m OH and 30m WP comes to Rs.26,656/-.

The matter was placed before the Full Time Directors as per the note read as 3rd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 29.06.2021 resolved to accord sanction to the Executive Engineer, Electrical Division, Muvattupuzha to effect the agricultural service connection to Sri. C.M. Paulose, Cherakkunnath House, Chathamattom P.O under Electrical Section, Pothanicadu at the estimated cost of Rs.26,656/- using Board's fund, considering that the application was received in Santhwanasparsham Adalath 2021 and that the petitioner had applied for free connection before the issuance of Board order dated 28.10.2011.

Orders are issued accordingly.
