One Time Settlment Scheme (OTS-2022) - extending for Cable TV operators - sanctioned - Orders issued.

ORDER

As per the BO read as 2nd above, OTS-2022 scheme is implemented in KSEBL with the approval of KSERC from 21.03.2022 to 20.05.2022. The above scheme allows consumers with arrears above two years to get reduced interest rates for favour of settlement. The Director (D&IT) as per the note read as 3rd above had requested to include arrears of Cable TV operators under the OTS-2022 scheme, in compliance to the earlier Director Board decision.

Earlier, the Director Board as per the order read as 1st above has accorded sanction to include Cable TV operators with pole rental arrears for more than two years also under the OTS scheme, with similar terms and conditions of OTS of current charge arrears. In compliance to the above, the Chief Engineer (Commercial & Tariff) as per the note read as 4th above has placed the matter before the Full-Time Directors.

Having considered the matter in detail, the Full Time Directors in its meeting held on 30.04.2022 has resolved to accord sanction to settle the arrears with respect to the Cable TV operators in similar terms and conditions as per the approved OTS-2022 scheme.

Further, resolved that the application for the same shall be received at the concerned Electrical Division and then forwarded to the Electrical Circle for settlement. The Deputy Chief Engineers of all Electrical Circles shall settle the arrears without limit in similar terms and conditions as per the OTS-2022 scheme.
