ORDER

In connection with implementation of AMR metering for the HT/EHT Consumers, KSEBL as per Order read as 1st above has issued directions to insist all the new HT consumers to install 3 CTs of accuracy class 0.2S and PTs of accuracy class 0.2 from 1st November 2016 onwards and insist all new HT/EHT consumers to procure DLMS compliant meters along with modem as per approved new specification either from KSEBL or approved vendors published by KSEBL from 1st January, 2017 onwards.

During 2019, Administrative Sanction was accorded for giving HT supply to Dr. Shani M.M., Superintendent, General Hospital, Muvattupuzha under Electrical Section, Muvattupuzha No.1. While processing the application it was noticed that the CT/PT/ToD

Metering equipments of old specifications are being procured. The Assistant Engineer, PWD Electrical Wing Section, Muvattupuzha has requested to effect HT service connection with CT/PT ToD meter as per old specification, considering the emergency load demand in the hospital. Also, as the metering equipment has already been purchased and tested by the TMR testing wing, and being a Government Institution, it is difficult to change the already purchased CT/PT ToD meter causing additional financial burden and further delay.

Based on the recommendation of the Deputy Chief Engineer, Electrical Circle, Perumbavoor, considering public interest and the firm being a Government Hospital, as per letter read as 3rd above, sanction was accorded to effect HT service connection with the procured CT/PT ToD meter, for a time period of 6 months from the date of energization as per old specification.

The HT connection was effected on 10.01.2019 with the then procured CT/PT/ToD meter of low accuracy. Though the granted time period was expired, the units were not replaced even after a lapse of 21 months. The Deputy Chief Engineer, Electrical Circle, Perumbavoor as per letter read as 5th above has reported that the consumer has requested time extension for replacing the Meter and associated equipments for a further period of 6 months stating their inability to incur the amount required in view of Covid -19 pandemic situation.

The matter was placed before the Full Time Directors as per the detailed note read as 6th above. Having examined the matter in detail, the Full Time Directors in the meeting held on 04.11.2020, resolved to accord sanction to consider the request of Superintendent, General Hospital, Muvattupuzha for extending the time period for replacing the metering equipments of General Hospital, Muvattupuzha upto 31.03.2021, the consumer being a Government Institution, with specific direction that no further extension will be granted after this period.

Orders are issued accordingly.
