ORDER

Miss Mereena Chacko, a class 12 student, and her younger sister a class 9 student had submitted an e-petition before the Hon'ble Chief Minister of Kerala, as per letter read as 3rd above, requesting for electric connection to their house located at Mukkada, Udayagiri Village of Kannur district for attending online classes.

The Assistant Engineer, Electrical Section Karthikapuram, as per letter read as 4th above, has reported that Smt. Kathrina Chacko (mother of Mereena Chacko) belonging to BPL category had applied for an electric connection to the newly constructed house at Mukkada, with a connected load of 440W. The said house is located in a hilly and isolated location and requires construction of 250 m overhead (OH) line for providing electric connection, for which an estimate amounting to Rs.1,14,169/- has been prepared.

Since KSEBL has accorded sanction as per BO read as 1st above, to issue free connection to the applicants under BPL category that require construction of OH line up to a maximum of 200m, the

above applicant is not eligible for free connection. The applicant has requested for free connection since they belong to BPL category so that her children could attend the online classes being conducted as schools have been shut down due to COVID Pandemic.

In the wake of the news in the print and visual media regarding students unable to attend online classes due to their houses not being electrified, the office of Director(Distribution, IT&HRM) had issued directions as per letter read as 5th paper above, to take up the cases where the stipulated limit of OH line as specified in the Board Orders are exceeded for effecting service connection to BPL household after ascertaining its genuineness, for obtaining special sanction of the Board.

The Chief Engineer Distribution (North Malabar) and the Deputy Chief Engineer, Electrical Circle Sreekandapuram vide letters read as 6th and 7th above respectively, has forwarded the request of the above applicant and requested sanction for effecting free service connection to Smt. Kathrina Chacko belonging to BPL category by constructing 250 m Overhead line, using KSEBL's fund, as a special case, considering their poor financial condition. The matter was placed before the Full Time Directors for a decision as per Note read as 8th above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 09.09.2020, resolved to accord sanction for effecting free service connection to house of Smt. Kathrina Chacko, belonging to BPL category, by constructing 250m Overhead line under Electrical Section Karthikapuram, using KSEBL's fund, as a special case

Orders are issued accordingly.
