- 1 Tenders for the subject work are invited in single cover system. The bid documents and other details may be downloaded from the website [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in). **The EMD of Rs. 18,713/- and non-refundable bid submission fee of Rs.1,770/- for GST unregistered/GST registered shall be remitted online through State Bank of India MOPS only.** Mode of payment other than Internet Banking will not be allowed. Bidder should ensure that bid submission fees and EMD are remitted as one single transaction and not separate. Separate or split remittance for bid submission fee and EMD shall be treated as invalid transactions.
- 2 The bid document is available online and bids are to be submitted online through e-tendering portal [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in). The bidders would be required to register in the web site which is free of cost. For submission of bids, the bidder is required to have Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities (CA).

- 3 Aspiring bidders who have not obtained the user ID and password for participating in e-tendering may obtain the same by registering in the web site [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in).
- 4 Digital Signature is mandatory to participate in the e-tendering. Bidders already possessing the digital signature issued from the authorized CAs can use the same in this tender. Only eligible bidders with following key qualifications shall participate in this bidding.
- 5 Eligibility of Tenderer: Experience in execution of similar painting works costing not less than 40% of PAC. Experience certificate to be uploaded along with the bid document.
- 6 The scanned copy of Bounden agreement, Qualification Information, and other Documents in accordance with the Section 1 & Section 2 shall be uploaded through the e-tender web site.
  - (a) The percentage Bill of Quantities (BOQ 1 & 2) is to be filled. Rate of GST is @18% for GST registered contractors and @ 0% for the GST unregistered contractors and is to be filled in BOQ 2.
  - (b) The bidders are required to submit the bid “online” only and shall not be considered when submitted by any other mode
- 7 If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
- 8 The bids for the work shall remain valid for acceptance for a period of 90 days from the date of opening of bid.
- 9 Other details can be had from the bidding documents. The Employer shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the bidders of any bid updates, the Employer shall not be liable for any information not received by the bidder. It is the bidders’ responsibility to verify the website for the latest information/corrigendum related to the bid.
