ORDER

The Administrative Sanction was received, as per the Government Order read as 1st above, for an amount of Rs.298.38 Cr for the development of Kole Area in Thrissur - Ponnani (“ Improved Infrastructural facilities to overcome flood and drought in Thrissur Ponnani Kole lands for increased paddy production”) under 'Rebuild Kerala Initiative Project'. Out of this, towards the 1st phase of 'Rebuild Kerala Initiative Projects' an amount of Rs.3.76506 Cr. was apportioned as fund for KSEB Ltd for the work of Installation of Transformers and Communicative Fault Pass Detector (CFPD).

Accordingly, in coordination with the Agricultural Department and other concerned agencies in Electrical Circles Thrissur, Shornur, Tirur and Irinjalakuda, 126 works amounting to Rs.8,93,74,389/- were identified.

KSEBL as per the Board order read as 2nd above had issued sanction to the Deputy Chief Engineers of Electrical Circles Shornur, Tirur, Irinjalakuda and Thrissur to carry out the 63 nos of works identified under their Circles at an estimated amount of Rs.3,76,49,114/- out of the 126 works with a total estimate amount of Rs.8,93,74,389/-.

The Chief Engineer Distribution (Central), as per the letter read as 3rd above, has informed that as per the direction of the Agricultural Department and on the re-inspection of different Kole Development Committees and KSEBL, some more works had to be incorporated in the project. Hence, the Nodal Officer, the Deputy Chief Engineer, Electrical Circle, Thrissur has submitted a revised estimate amounting to Rs.9,53,71,254/- for a total of 129 works in

phase I and II of the project. The estimate includes Rs.9,19,86,250/- towards line works ; Rs.7,58,440/- towards CD amount and Rs.26,26,564/- towards Service Connection Amount (ECSC/Additional ECSC amount).

Out of the total estimated amount of Rs.9,53,71,254/-, an amount of Rs.40,28,796/- has been estimated for 3 works in Shornur Circle, Rs.2,31,05,221/- for 27 works in Tirur Circle, Rs.4,92,34,648/- for 72 works in Thrissur Circle and Rs.1,90,02,589/- for 27 works in Irinjalakuda Circle.

Hence, the revised sanction is requested for the estimate amounting to Rs.9,53,71,254/- for the Phase I and II of the subject project.

The matter was placed before the Full Time Directors as per the note read as 4th above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 24.06.2021, resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Shornur, Tirur, Irinjalakuda and Thrissur to carry out the 129 nos of works identified under Electrical Circle Shornur, Tirur, Irinjalakuda and Thrissur, at an estimated amount of Rs.9,53,71,254/- for phase I and II, as part of the project "Improved infrastructural facilities to overcome flood and drought in Thrissur Ponnani Kole lands for increased paddy production" under Rebuild Kerala Initiative Projects, subject to the condition that sanction from Rebuild Kerala shall be obtained and availability of funds shall be ensured.

Further resolved to modify the Board Order dated 28.01.2021 to this extent.
