## **ORDER**

The Executive Engineer, Electrical Division, Neyyatinkara, as per letter read as 4<sup>th</sup> above, requested facility in the OrumaNet software for allowing free electricity (above 100 units per month) for patients surviving on life support systems, in the matter of a request for concession in electricity charges for Sri Lijo Chellappan, under Electrical Section, Parassala.

Sri Lijo, who has been residing in a rented house near Bhaskar Nagar at Kedavilakom under Electrical Section, Parassala since 2/11/2020, is on ventilator support for survival.

Sri Lijo's brother Vipin who takes care of him, approached the Assistant Engineer, Electrical Section, Parassala, for concession in his electricity bill for the period 7.11.2020 to 7.1.2021, during which his consumption was 766 units. (The bill amount is ₹ 6069/-as per OrumaNet records)

The Assistant Engineer, who visited the premises of the Consumer No. 1145400021920 reported to the Executive Engineer, that the entire life sustaining equipment for Sri Lijo, would consume around 15 units per day and that there are only ten 9 Watt LED bulbs and two 60 W fans (which would consume around 1.03 units per day) in addition to the life sustaining equipment in the entire house. The bimonthly consumption for life supporting system would therefore be 900 units and for other uses, 62 units.

The Executive Engineer also forwarded a copy of the certificate dated 29<sup>th</sup> January 2021 from Dr Sanjeev Thomas, Professor of Neurology and Head of the Department, Sri Chitra Thirunal Institute for Medical Sciences and Technology, Trivandrum, issued to the Assistant Engineer, Electrical Section, Parassala after examining Sri Lijo at his place of residence on 19/1/2021, in support of his application for waiving electricity charges.

The Executive Engineer, intimated that the OrumaNet software facilitates the accounting of free electricity for a maximum of only 100 units per month at present and requested that modification (as was required to be made vide the BO read as 4<sup>th</sup> above), be done now in the software so that the consumer can avail the full benefit as per the Government and Board orders. The Executive Engineer has also requested to give sanction for manually revising the bill till the requisite software modification is brought in.

The matter was placed before the Full Time Directors as per note read as 8<sup>th</sup> above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 8/2/2021,

1. Resolved to accord sanction to waive collection of electricity charges from the consumer Sri Lijo presently on life supporting and life sustaining ventilator, residing in a rented premises, with consumer number 1145400021920 under Electrical Section, Parassala, till further orders, considering this as a very special case, on humanitarian grounds, and considering that there are only minor electrical equipment in his house other than the life sustaining ones for Sri Lijo.

2. Further resolved to direct the Executive Engineer, Electrical Division, Neyyattinkara, to ensure that the concession given for bimonthly consumption over and above 200 units is accounted in the head of Accounts 28.625 as per the proceedings No. Annual Accounts -IX/AC-II/2/2012-13 dated 7/11/2012 of the Financial Adviser, so as to claim this from the Government.

Orders are issued accordingly.
