## **ORDER**

The Chief Engineer, Distribution South has as per letter read as 3<sup>rd</sup> above has sought sanction for placing work order with the single bidder for carrying out the PMU work of drawing 2 km of OH line from Pasuvannara to Thelikkuzhy and laying 70 m of UG cable with a PAC of ₹5,80,627/-, under Electrical Section, Marayamuttom. The Chief Engineer reports that the first tender for the work had to be cancelled owing to non participation and the retender brought only a single bidder, Sri Suresh Kumar, Laxmi Electricals, Ambalathara, who has quoted 17.2% below estimate rate and that the chances of obtaining a better competitive rate even on retendering is less.

The Chief Engineer requests sanction for awarding the work to Sri Suresh Kumar.

As per Clause 4(d) (iv) of G.O. read 1<sup>st</sup> above, a single bid during re-tender shall be accepted only with the approval of Committee of Secretaries/Government Tender Committee or a Committee headed by the Head of the Department/Institution, with Finance Officer (or equivalent) and the Tender Inviting Authority as members, as per delegation of tender acceptance in force.

As per the BO read as 2<sup>nd</sup> above, the Circle level committee is delegated to sanction the single quotation/tender received for offers to carry out the Dyuthi project petty contract

works at estimate amount / below estimate amount after re-tendering, and the Chief Engineer level committee is delegated to sanction the single quotation / tender received for offers to carry out such works with overall tender excess of up to 5% above PAC after re-tendering, for all works with PAC up to ₹ 5 Lakhs only.

Since PAC in case of the work exceeds ₹ 5 Lakhs, the matter was placed before the Full Time Directors for a decision, as per note read as 4<sup>th</sup> above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 23/04/2021, resolved to accord sanction to the Chief Engineer (Distribution South), for accepting single tender for the execution of the PMU work of drawing 2 km of OH line from Pasuvannara to Thellikkuzhy and laying 70 m of UG cable with a PAC of ₹5,80,627/-, under Electrical Section, Marayamuttom, for which only single tender was received on re-tendering, and for awarding the said work at 17.5% below the estimate rate as quoted by the single bidder, Sri Suresh Kumar, Laxmi Electricals, Ambalathara, considering the Chief Engineer's remark that the chances of obtaining a better competitive rate is less, and also to avoid delay.

Orders are issued accordingly.
