### **ORDER**

The matter of processing the application for enhancement of connected load from Kerala Water Authority Pump house, LCN 2/3222, an HT consumer under Electrical Section, Punalur (with a pending arrear of ₹1,15,61,001/-during the period from 6/2019 to 12/2020) for enhancing contract demand from the existing 250 kVA to 498 kVA and connected load from 528KW to 715KW+187KW (stand by), was taken up with the Director (Finance) as per Note read as 1<sup>st</sup> above and as per the direction from the Director (Finance), the consumer was asked to remit their arrears before getting their load enhanced.

As reported by the Deputy Chief Engineer, Electrical Circle, Kottarakkara , M/s KWA was intimated of the decision to enhance their demand only on payment of arrears, and new demand was also intimated to them on 14.1.2021.

The Deputy Chief Engineer, Electrical Circle, Kottarakkara reported as per letter read as 3<sup>rd</sup> above that M/s KWA has remitted an amount of ₹81,57,193/-on 10.3.2021, the arrears reported by the Special Officer, Revenue as on 27/8/2020 and demanded then. The up to date arrears (as on the date of payment) was however ₹1,13,45,810/, as intimated by the SOR. An amount of ₹31,88,617/- is still pending against the consumer.

The Deputy Chief Engineer sought sanction for enhancement of load, considering the amount KWA has paid towards current charge arrears and Security Deposit (The Executive Engineer,

KWA Project Division, Kollam had remitted ₹25 lakhs as GD on 19/2/2020 for the enhancement before submitting the completion report, as the amount was to be remitted by NABARD and its period was to expire before 9/2019 ) and considering the drought situation, for proceeding with the agreement for enhancing the Contract Demand and Connected Load of M/s KWA Pump House, Punalur.

The matter was placed before the full time Directors as per note read as 5<sup>th</sup> above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 26/03/2021, resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Kottarakkara to process the application for enhancement of connected load from Kerala Water Authority Pump house, LCN 2/3222, HT consumer under Electrical Section, Punalur (with a pending arrear of ₹31,88,617/- (Rupees Thirty one lakhs eighty eight thousand six hundred and seventeen only)) for enhancing contract demand from the existing 250 kVA to 498 kVA and connected load from 528KW to 715KW+187KW (stand by), considering that an amount of ₹81,57,193/-, a considerable portion of the total arrears (amounting to ₹1,13,45,810) has been remitted by KWA towards current charge arrears on 10.3.2021, and considering that an amount of ₹25 Lakhs has already been remitted by them towards Security Deposit.

Orders are issued accordingly.
