Distribution Plan 2019-20 – remittance of road restoration charges as Bank Guarantee, remittance of Licensee fee through the Portal for MORTH (Ministry of Road Transport & Highways) and execution of agreement - sanctioned- Orders issued.

ORDER

The Chief Engineer (Distribution South) as per letter read as 1st above has reported that as part of the Distribution Plan 2019-20, there are proposals to replace the existing 3x150 mm² UG cable from Killipalam RMU to Elankom RMU with 3x300 mm² XLPE UG cable and also to shift the 11 kV UG cable presently lying inside Killi river to the side of Killipalam bridge. The cable from Killipalam RMU to Elankom RMU is to be laid through the existing duct in the National Highway from Killipalam to Karamana for 560 m. For the second proposal, GI pipe is to be clamped by the side of Killipalam Bridge and cable is to be looped through the pipe.

The proposals were taken up with the NH authorities by the Executive Engineer, PMU, Thiruvananthapuram, for obtaining permission for laying cable in the existing duct from Killipalam RMU to Elankom RMU and for clamping GI pipe in Killipalam Bridge and looping cable through it, following which, the Executive Engineer, NH Division, Thiruvananthapuram requested the following, for issuing sanction:

- 1. Submission of a performance bank Guarantee amounting to ₹66,080/-.
- 2. Remittance of ₹3,59,806/- towards License fee via the portal of MORTH (Ministry of Road Transport & Highways).
- 3. Execution of an agreement in prescribed format in ₹200/- stamp paper.

The Chief Engineer has pointed out that in a similar case for IPDS work under Electrical Circle, Kollam, KSEBL had accorded permission as per the BO read as 2nd above, to the Deputy Chief Engineer, Electrical Circle, Kollam, for remitting the road restoration charges and License Fee demanded by the NH authorities as per the Guide lines issued by MORTH and requested sanction to follow the procedures for remittance of road restoration charges as demanded by the NH authorities and to authorize the Executive Engineer, Electrical Division, Thiruvananthapuram to carry out the same.

The agreement to be executed was sent to the Senior law Officer for vetting and the Senior law officer as per note read as 4th above has remarked that the format of agreement is the one issued by the Ministry of Road Transport & Highway as policy guideline and that no illegality is noticed in it and can be accepted in toto.

The Executive Engineer, PMU, Trivandrum forwarded as per letter read as 5th above, the following details of the demand note issued by the NH authorities.

- The license fee is being demanded for a maximum of 5 years and is based on the formula –license fee in Rs /Sq km/month)=utilized land area X prevailing circle rate of land per unit area /(10X12), where utilized land area is Outer diameter /width of concerned utility line X length,.
 - The average land value of Manacaud Village from the Registration Department official website is ₹ 27225/Sq metre and the utilized land area is 560x0.04 =22.4 Sq metre and hence the license fee being demanded for 5 years is 22.4 X 27225 X 5 X12/(10X12)= ₹ 304920/. This, including a GST of 18% would amount to ₹ 359806/-.
- Rate taken for arriving at the amount for the performance Bank Guarantee is
 ₹ 100/m of duct length utilized.
 - Since the duct length is 560 m, the Bank guarantee including GST of 18% would come to ₹ 66,080/- (560X100 + 18% GST)

The matter was placed before the full time Directors as per note read as 6th above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 28/01/2021, resolved to accord sanction to the Chief Engineer, Distribution South to submit the Performance Bank Guarantee amounting to ₹ 66080/- and to remit ₹3,59,806/- towards license fee via the MORTH portal, and to execute the agreement in prescribed format, in

connection with the execution of works of 'replacing the existing 3X150 mm² UG cable from Killipalam RMU to Elankom RMU with 3X300mm² UG cable and shifting the 11kV UG Cable lying inside Killi river to the side of the Killipalam bridge', as part of the Distribution plan 2019-20 under Electrical Circle, Thiruvananthapuram.

Orders are issued accordingly.
