National Waterway Project- Kollam TS Canal development- request for shifting of electric posts –sanctioned- Orders issued.

ORDER

The Director, Irrigation Department, Inland Navigation Directorate, Kollam as per letter read 1st above intimated that as part of the development works of the Kollam TS Canal (which is a part of the National Waterway), two electric posts placed along the Kachchikkadavu bund have to be shifted for attending to the piling and slab works, and that the Executive Engineer, Electrical Division, Kollam has demanded the remittance of ₹ 40,012/- for carrying out the said shifting. The Director, Inland Navigation Directorate requested that the shifting be carried out urgently since the National waterway is scheduled for inauguration in Feb 2021 and promised that the amount would be remitted with KSEBL as soon as it is released from the Government.

The Executive Engineer, Electrical Division, Kollam as per letter read as 2nd above, furnished a report affirming that an estimate amounting to ₹40,012/- was prepared for the above works based on the request from the AEE, Inland Navigation Sub Division and that the Kollam Deputy Collector who had requested urgent completion of the works was informed that the said works could be completed on remittance of the required amount. It was also reported that the Director, Irrigation Department, Inland Navigation Directorate, Kollam had informed that the inauguration of National Water ways was expected during Feb 2021, and hence the shifting of the posts was urgent, and also that the required funds for executing the works would be remitted as and when funds were allotted by the Government .

The Executive Engineer sought directions on whether the above works be executed based on an undertaking from the Assistant Executive Engineer, Inland Navigation that ₹40,012/- will be remitted to KSEBL as and when funds are allotted from the Government.

The matter was placed before the full time Directors as per note read as 6th above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 28/01/2021,

Resolved to accord sanction to the Executive Engineer, Electrical Division, Kollam to carry out the shifting works of two electric posts alongside the Kachchikkadavu bund of the TS Canal, Kollam, for facilitating the piling and slab works in connection with the TS Canal development works as part of the National Waterway project, urgently, based on an undertaking from the Assistant Executive Engineer, Inland Navigation, that the estimate amount of ₹40,012/- for the said work will be remitted to KSEBL as and when funds are allotted from the Government.

Further resolved to direct the Executive Engineer, Electrical Division, Kollam, to carry out proper follow up measures to ensure that the amounts are remitted to KSEBL at the earliest.

Orders are issued accordingly.
