A non refundable tender document fee of Rs.5900/- (Rupees Five Thousand and Nine Hundred Only) Inclusive 18% GST and an Earnest Money Deposit Rs. 34500/- (Rupees Thirty Four Thousand Five Hundred only) shall be remitted to the account number in the remittance form provided by the e- procurement system for this particular tender. Only SBI/MOPS (State Bank of India Multi Option Payment System) Internet Banking remittance is allowed. Tender cost indicated is inclusive of Kerala GST @ 18%.
- IV. The offers shall be submitted in two cover system.
