- II. All bidders participating in the tender should have a valid Digital Signature Certificate availed from an approved certifying authority. All communications regarding the tender including queries if any shall be done online at the website www.etenders.kerala.gov.in.
- III. The details may be downloaded website bid documents and other from the www.etenders.kerala.gov.in. The EMD of Rs.50,000/- (Rupees Fifty Thousand Only) and the nonrefundable bid submission fee of Rs.5900/- (inclusive of GST @ 18%) i.e., a total Rs.55,900/-(Rupees Fifty Five Thousand Nine Hundred Only) shall be remitted online through internet banking only. Bidders should ensure that bid submission fees and EMD are remitted as one single transaction and not as separate payments. Separate or split remittance for bid submission fee and EMD shall be treated as invalid transactions. The online payment may be exercised at least 48 hours before the closing date of the bid to ensure that payment towards tender document fee and EMD are credited to the beneficiary account and a confirmation is reflected in the e-procurement system.
