#### **1. Security Deposit**

The selected bidder should furnish a Security deposit for 5% of the agreed amount. The security deposit shall be in the form of DD/BG from any Scheduled Commercial bank in favour of the Deputy Chief Engineer, Generation Circle, Thrissur payable at Thrissur for the execution of the agreement in Kerala Government stamp paper of appropriate value for the proper fulfillment of the contract and satisfactory completion of the work.

#### **2. Performance Security Deposit**
