### **Important Conditions:-**

#### **1. Security Deposit**

The selected bidder should furnish a Security deposit for 5% of the agreed amount. The Performance security shall be in the form of DD from any Scheduled Commercial bank in favour of the Deputy Chief Engineer, Generation Circle, Thrissur payable at Thrissur for the execution of the agreement in Kerala Government stamp paper of appropriate value for the proper fulfillment of the contract and satisfactory completion of the work.

#### **2. Performance Security Deposit**

The selected bidder should furnish a Performance Security deposit for 5% of the agreed amount by DD from any Scheduled Commercial bank in favour of the Deputy Chief Engineer, Generation Circle, Thrissur payable at Thrissur for the execution of the agreement in Kerala Government stamp paper of appropriate value for the proper fulfillment of the contract and satisfactory completion of work.

Performance security deposit including 5% Security Deposit make Performance Guarantee which will be 10% of PAC in the form of Bank Guarantee/DD drawn from Nationalized Bank or Scheduled Bank along with execution of agreement.

**The Performance Guarantee will be released to the contractor only after the expiry of Defect Liability Period.**

### **3. Additional Performance Guarantee**

If the rate quoted by the selected bidder is 'x%' below estimate cost (where x lies above 10% and up to 25%), he should furnish additional performance guarantee for an amount equal to (x-10)% of the estimate amount for the execution of the agreement.

Additional performance guarantee shall be in the form of DD from any Scheduled Commercial bank in favour of the Deputy Chief Engineer, Generation Circle, Thrissur payable at Thrissur. Or it shall be in the form of unconditional bank guarantee from any Scheduled Commercial bank valid till 28 (twenty-eight) days after the completion of the Work, in an approved format. The Bank Guarantee on instalment basis with lesser period validity shall not be accepted.

**The Additional Performance Guarantee will be released to the contractor only after satisfactory completion of the work without any interest.**

### **4. Defect Liability Period**

The defect liability period shall be **Sixty months** from the date of completion of the work. The contractor shall guarantee for the performance of the entire work and its components during this period.
