Kerala Government Public Sector Undertakings are exempted from furnishing EMD. State PSUs shall produce Certificate from Industries Department of Government of Kerala. MSME with Udyog Aadhar Registration are exempted from furnishing EMD and Bid submission fee on production of valid documents in support of claim. If the bidder is a New Entrant, EMD will be 10% of the total EMD amount which shall be remitted as specified in the New Entrant Clause (29) in Annexure-I (Part-I). In such case sufficient care shall be taken to make suitable selection in the e-tender site.

All Communications shall be addressed to the Chief Engineer(Distribution South) only. The Bid documents and other details may be downloaded from the website <https://www.etenders.kerala.gov.in>.

The EMD of Rs. 1500/- (EMD for New Entrant Rs. 1500/-) and a non-refundable Bid submission fee of Rs. 472/- (including GST), total Rs. 1972/- (Rupees One Thousand Nine hundred and Seventy Two only) shall be remitted online to the account number given in the remittance form provided by the e-procurement system for this particular bid. State Bank of India Multi Option Payment System (SBI MOPS Gateway) alone is allowed as Mode of Payment.

EMD amount above Rs.10 Lakh can also be submitted as Bank Guarantee (BG) in stamp paper worth Rs 500 with a minimum validity of 9 months from the date of opening of Pre-qualification Bid and a maximum upto the date of execution of Agreement.

(Bidder should ensure that bid submission fees and EMD are remitted as one single transaction and not separate. Separate or split remittance for bid submission fee and EMD shall be treated as invalid transactions, and system will automatically reject the tender. However this is not applicable in case EMD is submitted as Bank Guarantee)

Purchase preference/ Price preference will be allowed to PSUs & MSMEs functioning in Kerala State as detailed in Clause-24(a),(b)&(c) of Pre-qualification Condition - Part-I of this tender document.

The bid submission fee in respect of bids which are cancelled due to the reason/fault not from the bidder shall be refunded observing the same procedure as in the case of refund of EMD. The EMD and bid submission fee of the firms furnishing false information with fraudulent motive shall be forfeited.

All the Bid documents are to be submitted through online only and in the designated covers/ envelopes on the above website. Technical bid and financial bid shall be submitted in their designated online covers. **Bids shall be accepted only through online mode in the website and no manual submission shall be entertained. The scanned copy of Bid agreement as per Appendix-III-General Conditions of Contract & Schedule for the supply of material and Bid form mentioned in Annexure-IIi of Price bid (Part-III), both executed in Kerala non-judicial stamp paper worth Rs.200/- each are to be attached along with the bid.** The pre-qualification/ technical bid shall be opened online at the office of the Chief Engineer (Distribution South) on the date and time mentioned above by the Chief Engineer (Distribution South) in the presence of the bidders /their authorized representatives who wish to attend at the above address. All other existing conditions related to the bids of KSEB Limited will be applicable in this bid also.

Originals of Bid Agreement & Bid form in Kerala non judicial stamp paper worth Rs.200/- each enclosed in sealed envelope superscribing the bid number shall be submitted to the Chief Engineer (Distribution South) on or before the last date of Pre-qualification Bid opening.

Bidders should have a Class II or above Digital Signature Certificate (DSC) to be procured from any Registration Authorities (RA) under the Certifying Agency of India. Details of RAs will be available on www.cca.gov.in. Once, the DSC is obtained, bidders have to register on www.etenders.kerala.gov.in website for participating in this tender. Website registration is a one-time process without any registration fees. However, bidders have to procure DSC at their own cost.
