- II. All bidders participating in the tender should have a valid Digital Signature Certificate availed from an approved Certifying Authority. All communications regarding the tender including queries, if any, shall be done online at website http://etenders.kerala.gov.in. The bidders shall read the complete tender documents and technical specification as attached as annexures before submitting the bid.

only) and non - refundable bid submission fee of **Rs. 1770/-(Inclusive of GST @ 18%)** i.e., a total of INR. 19,820/-(Rupees Nineteen Thousand Eight Hundred and Twenty only) shall be remitted through internet banking. After evaluation of the bid the successful bidder shall execute an agreement in Kerala Govt stamp paper in the form prescribed by KSEBL for the due fulfillment of the contract within the period to be specified in the Work Order and shall furnish Security Deposit equal to 5% of the contract value before signing the agreement. Tenderers should be prepared to accept orders subject to an indemnity clause for forfeiture of security deposit in the event of default or failure to execute work within the stipulated period.
