General Tender Terms & Conditions for e-Procurement

This tender is an e-Tender and is being published online for the work "Re rerouting 11 kV line from Valiyavila Manakkara via Anjilimoodu using Covered conductor under ES Sasthamkotta.". The tender is invited in <u>Two</u> cover system from licensed / experienced contractors through e-procurement portal of Government of Kerala (https://www.etenders.kerala.gov.in). Prospective bidders willing to participate in this tender shall necessarily register themselves with above mentioned e-procurement portal.

The tender timeline is available in the critical date section of this tender published in www.etenders.kerala.gov.in

- A) Online Bidder registration process: Bidders should have a Class II or above Digital Signature Certificate (DSC) to be procured from any Registration Authorities (RA) under the Certifying Agency of India. Details of RAs will be available on www.cca.gov.in. Once, the DSC is obtained, bidders have to register on www.etenders.kerala.gov.in website for participating in this tender. Website registration is a one-time process without any registration fees. However, bidders have to procure DSC at their own cost. - B) Online Tender Process: The tender process shall consist of the following stages:
- i. Downloading of tender document: Tender document will be available for free download on www.etenders.kerala.gov.in. However, tender document fees shall be payable at the time of bid submission as stipulated in this tender document.
- ii. Pre-bid meeting: There will be no pre bid meeting
- iii. Publishing of Corrigendum: All corrigenda shall be published on www.etenders.kerala.gov.in and shall not be available elsewhere.
- iv. Bid submission: Bidders have to submit their bids along with supporting documents to support their eligibility, as required in this tender document on www.etenders.kerala.gov.in. No manual submission of bid is allowed and manual bids shall not be accepted under any circumstances.
- v. Opening of Bid: The bids will be opened, evaluated and shortlisted as per the eligibility.

All documents in support of technical qualifications shall be submitted online. Failure to submit the documents online will attract disqualification. Opening of Financial Bids: Bids of the qualified bidder's shall only be considered for opening and evaluation of the financial bid on the date and time mentioned in critical date's section.

- C). Documents Comprising Bid Based on one cover tender system The Bidder shall complete the Price bid as per format given for download along with this tender.
- d)The scanned copy of bounden agreement, the matter to be typed is attached to the tender form shall be executed in Kerala Govt. stamp paper worth Rs.200/- and to be accompanied along with the tender.

The tender shall be opened on line at the office of the Executive Engineer, Project Management Unit, Kollam on the date and time mentioned above by the under signed. All other existing conditions related to the bids of KSEB Limited will be applicable in this tender also. Originals of bounden Agreement in stamp paper worth Rs.200/- in a sealed envelope super scribing the tender number shall be submitted to the Executive Engineer, Project Management Unit, Kollam before the last date of tender opening.

Note: The blank price bid should be downloaded and saved on bidder's computer without changing file-name otherwise price bid will not get uploaded. The bidder should fill in the details in the same file and upload the same back to the website.

Fixed price: Prices quoted by the Bidder shall be fixed during the bidder's performance of the contract and not subject to variation on any account. A bid submitted with an adjustable/variable price quotation will be treated as non - responsive and rejected.

D). Tender Document Fees and Earnest Money Deposit (EMD) The Bidder shall pay, a tender document fees of *Rs.5900/-* (*Rs.5000/-* + *18%GST*) and Earnest Money Deposit or Bid Security of *Rs.50000/-*. The Bid security is required to protect against risk of Bidder's conduct, which would warrant the forfeiture of security. Online Payment modes: The tender document fees and EMD can be paid through SBI MOPS mode of online payment

<u>Single transaction for remitting Tender document fee and EMD</u>: Bidder should ensure that tender document fees and EMD are remitted as one single transaction.

Amount as per Remittance form: Bidder should ensure that the amount being remitted is neither less nor higher than the amount shown in remittance form.

One Remittance Form per Bidder and per Bid: The remittance form provided by e-Procurement system shall be valid for that particular bidder and bid and should not be re-used for any other

tender or bid or by any other bidder.

Any transaction charges levied while using any of the above modes of online payment has be borne by the bidder. The supplier/contractor's bid will be evaluated only if payment status against bidder is showing "Success" during bid opening.

E). SUBMISSION PROCESS: For submission of bids, all interested bidders have to register online as explained above in this document. After registration, bidders shall submit their bid online on www.etenders.kerala.gov.in along with online payment of tender document fees and EMD. For page by page instructions on bid submission process, please visit www.etenders.kerala.gov.in and click "Bidders Manual Kit" link on the home page. It is necessary to click on "Freeze bid" link/ icon to complete the process of bid submission otherwise the bid will not get submitted online and the same shall not be available for viewing/ opening during bid opening process.

Instructions to Bidders

- 1. Bid shall be submitted in the designated online cover
 - Scanned copy of bounden agreement in Kerala stamp paper worth Rs.200/-The original bounden agreement shall be sent in a single envelope superscribed as E-Tender No: ET No. 17/23-24/ Dtd 17.02.2024 and should reach before bid opening time to the tender inviting authority
 - b) Price Bid (BOQ) shall only be through online mode and no manual submission will be entertained. In the BOQ there are two sheets . The bidder shall quote percentage rate in the specified cell in the sheet 1 (BOQ1) of price bid and he/ she may enter "18" (existing GST rate) in the cell "M14" of BOQ sheet 2.
- 2. Bidders having License have to attach scanned copy of License certificate.
- 3. Bidders having experience have to attach scanned copy of experience certificate.

Acceptance of Bid and Award of Contract

On Final selection of bid for the work, the successful bidder will be informed at his address that his bid has been selected. The bidder will have to return a signed copy of this as a token of acceptance and the bidder should come forward to execute the contract. After which the final award of contract *(AOC)* will be issued online.

<u>Safety:</u> The contractor is responsible for the safety of all activities at the site. The Contractor should carry out all the instructions of KSEBL which are in conformity with the law.

<u>Corrections of Defects</u>: KSEBL will give notice to the contractor, if any defects are noticed, the contractor should correct the defects within the period specified in the notice.

<u>Changes in the activity schedule</u>: During the course of execution of work if it is found that any additioal work other than those mentioned in the schedule becomes necessary for the successful completion of the work, the contractor shall carry out all such works for which a variance will be ordered by KSEBL.
