1. **Executive Engineer, PMU, Kalpetta** invites online Bids for **Extension of 11 kV Vellarivayal Feeder from Karingari Kappela to Kaithakkettu by constructing a 3.6 km overhead line using HT ABC 150 sq mm and ACSR Raccoon conductors on A-type and PSC poles under Electrical Section Vellamunda as part of the Dyuthi 2.0 Scheme - Labour Contract** on behalf of Kerala State Electricity Board Limited. Bidders are advised to note the clauses on eligibility and qualification requirements in **Section 3** of Part B (1) in Bid Document, to be eligible and qualify for being considered for the award of the contract.
2. Bidding will be conducted through national open competitive e-procurement.

3. The Bid document is available online, free of cost, for downloading on www.etenders.kerala.gov.in from **18.09.2024 to 30.09.2024**. The bidder would be responsible for ensuring that any addenda/ corrigendum/ amendment etc. available on the website/ portal is also downloaded and incorporated.
4. The bidding shall be conducted **under Single Stage Two-Envelope Bidding process with e-Procurement** as specified in Part B (2) - Instruction to Bidders, in the Bid Document.
5. Under the Single Stage Two-Envelope Bidding process, **the Bidder shall not quote, disclose, or submit its price in the Technical Part (First Envelope) of its bid or in any other manner, whatsoever, except as part of the Financial Part (Second Envelope) of its bid.** In case of any non-compliance in this regard, the bids shall be out-rightly/ summarily rejected.
6. An incomplete and/or ambiguous and/or conditional bid and/or bid submitted late is liable to be ignored/ summarily rejected.
7. Bid must be submitted online through the e-Procurement/ e-Tendering process specified in Part B (2) - Instruction to Bidders - of the Bid Document. Any bid or modifications to bid received outside the e-Procurement system will not be considered, unless otherwise specified in the Bid Document. The Utility shall not be held liable for any delays due to e-Procurement/ e-Tendering system failure beyond its control. Even though the system will attempt to notify the bidders of any bid updates, The Utility shall not be liable for any information not received by the bidder. It is the bidders' responsibility to verify the website for the latest information related to this request for bid.

Brief description of Scope of Works	The work involves stringing 2.1 kilometers of 11 kV overhead line using HT ABC 3x150+1x120 sq mm cable and 1.5 kilometers of 11 kV overhead line with ACSR Raccoon on "A type"/PSC poles. Part of the line will follow the existing route, with additional poles added as needed, while the remaining section will require constructing a new line with new supports for the Vellamunda Section under Mananthavady Division. The project covers all items listed in the schedule, along with any additional tasks required to complete the work according to standard practices. The total length may vary slightly depending on site conditions during execution.
