3. **OPENING OF THE BIDS**

The bids will be opened on the date and time indicated in the invitations to bidder, in the presence of bidder's representatives who choose to attend and in the office of the Assistant Engineer, Maintenance Section -1, 220kV Substation, Brahmapuram Kochi - 682 303. The Bidder's representatives attending the same shall sign a register evidencing their attendance.

4. CONTRACTORS RESPONSIBILITES (LIABILITY)

- 4.1 The contractor shall be solely and exclusively responsible for the work.
- 4.2 The Engineer will determine whether the bidder is qualified to satisfactorily perform the contract or not and whether the tender is responsive and acceptable or not taking into account the price, quoted by the bidder, technical capabilities etc. It will be based upon the examination of the documentary evidences of the bidder's qualifications submitted by the bidder, as well as such other information as the Engineer (deems necessary and appropriate) may collect from other sources.

Any affirmative determination will be a pre-requisite for award of contract to the bidder. A negative determination will result in rejection of the bidder's tender, in which event; the Engineer will proceed to the next lowest evaluated tender to make a similar determination of the bidder's capabilities to perform satisfactorily.

- 4.3 The Engineer reserves the right to accept or reject any bid and to annul the biding process and reject all bids at any time prior to award of contract, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders of the grounds for the Engineer's action.
- 4.4. The final acceptance of the tenders will rest with the Engineer, who does not bind himself to accept the lowest or any tender without assigning any reason whatsoever.

5. AWARD CRITERIA AND SIGNING OF CONTRACT

- 5.1 Subject to Clause 4.3 the Engineer will award the contract to the successful bidder whose bid has been determined to be substantially responsive and at the same time notify the successful bidder that his bid has been accepted.
- 5.2 Within 7 days of receipt of acceptance, the successful bidder shall execute an agreement with the Board for the proper and satisfactory work.

6. SECURITY DEPOSIT

The successful bidder shall furnish the performance security deposit of 5% of the value of contract price by way of DD, which shall be kept valid throughout the period of contract along with the agreement. The SD will be refund only after successful completion of the contract.

7. <u>CONTRACT PRICE</u>

The prices shall remain FIRM for the entire duration of the contract and will not be subject to variation. The price quoted shall be exclusive of all types of taxes and duties such as GST, Income tax and also all other levies, fees etc. to be paid as per statutory requirements.

- 8. All the conditions prevail in KSE Board regarding contract for supply are applicable to this Contract also.
- 9. Payments will be made only after required checking and auditing. The amount of a bill will be arrived at based on the measured quantity for each item of supply and as per the agreed rates.

No work will be paid unless it is fully in accordance with the specifications and satisfaction of Engineer-in-charge. If by inadvertence, any bad work, incomplete work or unsatisfactory work happened to be passed and paid for, the Engineer-in-charge shall have the right to recover the amounts so made at any time.

If any amount due to the contractor by virtue of this contract, but not claimed for payment for three months from the date on which it falls due, the same will be placed on the deposit account and if it remain unclaimed for three years, the contractor shall have no claim on such amount and will be finally credited to the account of the Board.

9.1 Preparation and Payment of Bills

Final payments shall be made only when the Engineer-in-charge has given a certificate of completion of supply. Final measurements will be made on the completion of the work and payment will be given to the contractor on the basis of final measurements so taken, after adjustment of all outstanding recoveries and all amounts due to the Board as per the terms of the agreement. Payment of final bill will not be considered as a conclusive evidence for the sufficiency of any supply or material or correctness of measurements to which it relates and it shall not relieve the contractor from his liabilities arising from any defects.

9.2 Due Date of Payment

The agreement authority shall make earnest effort to make payments within 30 days from the date of submission of invoice / bill in full particulars in the prescribed form/format, by the contractor. Any delay in making payment due to any reasons shall not be a cause to the contractor for raising any claims for interest or other claims and shall not affect the supply in anyway.

9.3 Delayed Payment due to Dispute

No claim for interest or damages will be entertained by the Board with respect to any money or balance which may be lying with the Board owing to any dispute, difference or misunderstandings between the Engineer-in-charge on the one hand and the contractor on the other hand or with respect to any delay on the part of the Engineer - in - charge in making periodic or final payment of any respect whatsoever, and the Board shall not be liable to pay any interest or damages or loss to the contractor.

9.4 Bill Auditing

The measurements, account of materials and all relevant documents with respect to the part bill or final bill shall be subject to checking, scrutiny and auditing by the Engineer-in-charge and auditing by the Resident Concurrent Audit Officer of the Board or such other audit Officers authorised by the Board. The payment will be effected on completion of all such process.

9.5 Interim / Pre-payments

No interim/ pre-payments will be made in respect of individual bill before passing of the bill.

9.6 Payment Authority

The Deputy Chief Engineer, Transmission Circle Kalamassery is the payment authority General Conditions and Instructions to the Contractors prevailing in KSE Board is also applicable to this contract also.

10. NEGLIGENCE & TERMINATION OF CONTRACT

If the contractor shall neglect to execute the supply with due diligence and expedition or shall refuse or neglect to comply with any reasonable order given to him in writing by the Engineer in charge in connection with the supply, or shall contravene the provision of the contract, the Engineer-in-charge may give seven days' notice in writing to the contractor, to make good failure, neglect or contravention complained or and should the contractor fail to comply with the notice within reasonable time from the date of service thereof, in the case of failure, neglect or contravention capable of being made good within that time then and in such case, the Engineer-in-charge shall be at liberty to employ other person /agencies and forthwith perform such supply as the contractor may have neglected to do or if the Engineer-in-charge shall think fit, it shall be lawful for him to take the supply wholly or in part out of the contractor's hand and re-contract at a reasonable price with any other person/agencies for the purpose of effecting the supply or any part thereof, and the Board shall be entitled to retain and apply any balance which may otherwise be due on the contractor by them to the contractor or such part thereof as may be necessary to the payment of the cost of executing such supply as aforesaid.

11. BOARDS RIGHT TO EXECUTE THE WORK

The Board reserves the right to execute any portion of the contract either themselves of otherwise without assigning any reasons thereof and in such an event the contractor will have no claim for any compensation whatsoever. In case when the supply is supplemented or arranged otherwise due to default on the part of the contractor, the provisions under termination of contract shall apply.

12. EXTENSION OF CONTRACT

The Board reserves the right to extend the period of contract if it seems fit under the same existing terms and conditions and the contractor should agree the same.

13. No other facility of KSE Board will be provided at any circumstances to the contractor.

14. DAMAGE TO BOARD'S PROPERTY

None of Board's properties shall be damaged by the contractor under any circumstances.

15. <u>LIQUIDATED DAMAGES</u>

If the contractor fails to perform the contract within the time fixed under the contract or any extension sanctioned thereof, the contractor shall be liable to pay 0.5% of the contract price for each week or part of a week of such delay to compensate for the delay in the commercial use of the equipment. Such damages shall not in any case exceed 5 % of the contract price. For the calculation of liquidated damages, the date of delivery will be taken as the date of arrival of the equipment at site.

16. JURISDICTION

Only courts situated at the Head Quarters of the Board will have jurisdiction to entertain civil suits arising out of or on the application of this contract.

17. LOCAL LAWS:

All local laws in force at the time of entering into the contract and those enacted thereafter shall be binding on the Contractor and he shall abide by the same. The Contractor shall also be liable to all relevant provisions of the Indian Income-Tax Law, which may be applicable to him.

18. FORCE MAJEURE

A force majeure is herein defined as any cause which is beyond the control of the Contractor or K.S.E. Board and include the following: -

Act of God, war, preparation of war, intervention of Naval or Military Executives or other agencies of Government or occasioned by failure or refusal thereof to issue necessary approvals, arrests and restraints of rulers and people blockade, sabotage, vandalism, insurrection, landslides, floods, earthquakes, collisions and fire.

19. PERIOD OF CONTRACT

From the date of the agreement the work expected to be completed within Three months.

20. RELEASE OF SECURITY DEPOSIT

The security deposit shall, subject to the conditions specified therein be returned to the contractor soon after the satisfactory receipt of the material and execution of the performance guarantee, but in the event of any dispute arising between the Board and the contractor, the Board shall be entitled to deduct out of the deposit or the balance thereof until such dispute is determined, the amount of such damages, costs, charges and expenses as may be claimed.
