1. Person having valid PAN card & GST Registration Certificate can only be eligible to participate in the Tender cum Auction.
2. Tender form will not be available by post and can be had from the office of the undersigned during office hours on working days. Also tender form can be down loaded from the official website of the KSE Board (www.kseb.in) and cost of tender form should be separately attached along with the tender in the form of crossed DD from any Nationalized/Scheduled Bank, in favour of Deputy Chief Engineer, Electrical Circle, Tirur payable at SBI, Tirur
3. **All tenders should be accompanied with crossed DD from any Nationalized Bank for EMD as specified in the notice or 10% of the quoted amount whichever is higher** drawn in favour of the Deputy Chief Engineer, Electrical Circle, Tirur, payable at SBI, Tirur branch.
4. Participation in tender is not a precondition for participation in auction, but will be permitted if Photo copy of **EMD** attached with the tender is produced with application.
5. Tenders will be opened only after the completion of the auction on the same day.
6. Persons taking part in Auction should remit EMD by crossed DD of any Nationalized/Scheduled Bank, drawn in favour of the Deputy Chief Engineer, Electrical Circle, Tirur, payable at SBI, Tirur branch and report at Electrical Circle office, Tirur on **10.09.2024**, between 10.00 am and 10.30 am along with the application in white paper, proof of identity (**Voter ID/Driving license/Passport**), Copy of PAN card & GST Registration Certificate.
7. The person who possesses the token issued from this office will only be allowed to participate in the auction for the particular items.
8. **The quoted/offered rate should be excluding all GST, additional all taxes other expenses.**
9. The successful auctioner must remit **50 % of the bid amount** including EMD on the same day itself. Balance amount with statutory taxes should be remitted within 7 days of intimation
10. If the tender is highest, the tenderer should be remitted the balance 90% amount with all statutory taxes within the 7 days of intimation.
11. If the auction date / last date of receipt / last date of issue falls on a public holiday, the same will be conducted on the next working day at the same place and time.
12. The articles to be tendered can be inspected during working hours at SRS Tirur, No sorting of scrap materials for selection will be permitted while lifting. In case of articles are not lifted within the time limit allowed by the KSEB Limited, floor rent will be realized.

14. No consideration or preference will be given to any person/firm in this tender cum auction under any circumstances and no person/firm is exempted from remitting EMD.
15. The EMD of the second highest will be retained in this office till the first highest remit at least 50% of the sale amount.
